Auctioneers Bernaerts LTD is a public limited liability company under Belgian law, whose registered office is established at 2000 Antwerp, Verlatstraat 16-22.

1. When does this Privacy and Cookie policy apply?

This Privacy and Cookie policy applies to the processing of personal data via the websites of Auctioneers Bernaerts LTD and the companies associated Auctioneers Bernaerts LTD (including www.bernaerts.be).

2. Who is responsible for the processing of your personal data?

Auctioneers Bernaerts LTD is the party responsible for the processing of your personal data.

3. For what purposes do we process your personal data?

a. In order to respond to your requests and keep you informed

We process your personal data when you, e.g. by signing up for our newsletter or by requesting a brochure, ask to be kept informed of our activities, events and so on.

For this we can process data such as your name, your address, your e-mail address, your telephone number, your preferred language and the project or the region in which you are interested.

Depending on the individual case, these data are processed on the basis of your unequivocal consent, on the basis of the execution of a contract to which you are a party, or on the basis of your request to take steps for concluding a contract.

b. In order to answer your questions and exchange information

If you ask us questions by telephone or e-mail, we will process your personal data in order to respond to your question.

For this we can process data such as your name, your company name, your position, your e-mail address, your telephone number, your correspondence with Auctioneers Bernaerts LTD and all other personal data that you provide to us that can be relevant for answering your question.

Depending on the individual case, these data are processed on the basis of your request to take steps for concluding a contract, on the basis of the execution of a contract to which you are a party, or on the basis of Auctioneers Bernaerts LTD's legitimate interest in informing you about its activities.

c. For the technical and functional management of our website

We process personal data for the technical and functional management of our website, in order to personalise the website and to ensure that the website is easy to use.

For this we can process statistic data such as your IP address, the pages you visit, the browser you use, the websites you visited earlier, geographical data such as your location, your preferred language and the time and duration of your visit. We do this e.g. by using cookies. See also question 5: what cookies does Auctioneers Bernaerts LTD use?

These data are processed on the basis of Auctioneers Bernaerts LTD legitimate interest in improving its websites and protecting against cyber attacks and so on.

d. Internal processing of your customer data as (potential) buyer or contributor.

We process data that we receive from you when you come in person, contact us by telephone or e-mail, or when you register yourself on our website:

To be able to verify your identity, you may be asked to e-mail or scan a scan or photo of your identity card or passport.

In order to enable us to offer our services, we process your address, name, first name, full address, e-mail address (es), telephone number (s), preferred language.

If applicable also your bank account number, bic code, billing address, billing e-mail address, taxnumber, company website, the history of your brought in or purchased items, subscription data on the printed catalogs.

The necessary documents, such as invoices, expert reports, are sent via e-mail by standard with an attachment in PDF format. In the absence of a correct e-mail address, the documents are sent by post.

4. Who has access to your personal data?

Auctioneers Bernaerts LTD can share your data with other systems associated with Auctioneers Bernaerts LTD. In addition, Auctioneers Bernaerts LTD calls upon third parties to perform certain (processing) activities, such as hosting the website, the management of mailing lists, backups of so called 'mirror servers'. Personal data are not provided to other parties, unless this should be required by law or a court order.

5. What cookies does Auctioneers Bernaerts LTD use?

Cookies are small text files that are installed by your browser. They contain information such as the language preference of the visitor, so that he or she does not have to enter this information again during a subsequent visit to the same website. Some cookies ensure that a website has a sharp graphic appearance, others that a website application

works correctly.

If you wish to block cookies, you can do so via your browser settings.

8. How are your personal data protected?

Auctioneers Bernaerts strives to protect your personal data as well as possible by means of technical and organisational measures, such as firewalls and secure servers. Only the most necessary personal data will be saved on the website, and the data will be exchanged with our intern administration system (intranet) via a secured connection (API).

9. Who can you contact in order to exercise your rights?

You are entitled to request access - at no expense - to the personal data that are processed by Auctioneers Bernaerts LTD, to have them corrected or to object to having them processed for direct marketing purposes.

If the processing of your data is based on consent, you also have the right to withdraw your consent at any time, without this affecting the lawfulness of the processing done prior to the withdrawal of your consent.
